Pamela Wu is the Executive Director of Marketing and Communications at the University of California, Davis, School of Law, ranked among the top law schools in the nation. She is responsible for the law school's strategic communications in marketing, media relations, social media, and website development.

Pamela joined UC Davis in 2009, after more than a decade as a television news anchor and reporter. During her news career, she reported on stories ranging from presidential elections to red carpet events in Hollywood. She has been on the front lines of some of California's most devastating floods and fires. She was nominated for an Emmy award for her work as host of the cultural affairs program, "KCRA 3 Common Ground," and received the Unity Award in Media for political reporting.

Pamela continues her career in broadcasting as a documentary host and contributor for Capital Public Radio. She is the substitute host for Insight, the station's daily public affairs program. She hosted a health care documentary that won the 2012 Edward R. Murrow Award.

She is a member of the national Board of Directors of the Asian American Journalists Association (AAJA) and founding co-director of AAJA's Media Institute. In 2015, she was named AAJA's Member of the Year for excellence in service to the organization and the journalism industry.

Pam holds a degree in Rhetoric and Communication from UC Davis, where she was a member of the prestigious Integrated Studies Honors Program.

HONORABLE FIONA MA, CA STATE BOARD OF EQUALIZATION

As one of the few Certified Public Accountants to serve on the California State Board of Equalization, Fiona is uniquely qualified to represent nearly ten million Californians in the 23 counties in the Second Equalization District. Elected in November 2014, Fiona has a proven track record of working for our Asian Pacific Islander (API) community. She is a strong voice for businesses and taxpayers. While on the Board, she created a variety of taxpayer-friendly publications and web resources in Chinese geared towards specific industries such as restaurants and acupuncturists to help answer tax questions.

As a small business owner, Fiona served as President of the Asian Businesses Association in San Francisco, igniting her passion for public service. Fiona was later elected to represent District 4 on the San Francisco County Board of Supervisors from 2002-2006. While serving on the Board of Supervisors, she led the effort to create San Francisco's Disadvantaged Business Enterprise Program and combat human trafficking by making it more difficult for illegal massage parlors to open. During her tenure in the Legislature, Fiona represented the 12th Assembly District from 2006-2012 and served as Majority Whip and then the first Asian-American female Assembly Speaker pro Tempore in California history.

She is currently the President of the Asian American Donor Program; Co-founder, Honorary Chair, and Spokesperson of the San Francisco Hep B Free Campaign; and Treasurer of Curry Without Worry. Fiona is a Central Pacific Honorary Regional Board Member of the Anti-Defamation League, Honorary Board Member of Caregivers, and Board Chair of the Nurse Family Partnership. She serves on the Advisory Boards of the New Leaders Council, Asian American Donor Program, US Pan Asian American Chamber of Commerce Western Region, Mixed Roots Foundation, and Alliance for Girls. She has served as the President and Treasurer of California Women Lead and Board Member of Asian, Inc. She is also a member of the Screen Actors Guild, Aspen Institute's 2009 Class of Aspen-Rodel Fellows, and the California Film Commission.

Fiona received her B.S. in Accounting from the Rochester Institute of Technology (NY), her M.S. in Taxation from Golden Gate University (SF), and an MBA in Business Taxation from Pepperdine University. She has been licensed in California as a CPA since 1992.



COMMISSIONER JOSEPH A. FARROW
California Highway Patrol

Appointed in 2008 by Governor Arnold Schwarzenegger and reappointed in 2011 by Governor Jerry Brown, Joseph A. Farrow is Commissioner of the California Highway Patrol (CHP). With a Department of more than 12,000 employees, Commissioner Farrow commands the fifth largest law enforcement agency in the nation. Commissioner Farrow was born in Tokyo, Japan, and is the first Japanese-American to serve as the Commissioner in the CHP's history.

Commissioner Farrow joined the ranks of the CHP in 1979, when he entered the CHP Academy. Throughout his career, Commissioner Farrow has demonstrated an unwavering commitment to developing, implementing, and improving traffic safety programs and technologies within the State of California. Commissioner Farrow holds a Bachelor of Arts in Criminal Justice from California State University, Sacramento, and a Master's Degree in Executive Leadership from San Diego State University.

Commissioner Farrow has been recognized and endorsed for his career-spanning innovative leadership approaches in public administration. He is a member of the International Association of Chiefs of Police, the National Asian Peace Officers Association, and has been involved with the Asian Pacific State Employees Association's (APSEA) Navigating Leadership Program since its inception in 2012. Commissioner Farrow is currently a member of the Board of Advisors for APSEA's Navigating Leadership Program, and his leadership qualities have earned him the selection as an APSEA keynote speaker, as well as serving as a panelist on several occasions.

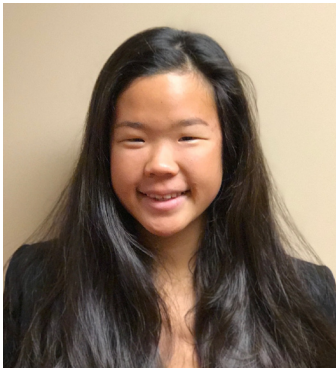
DEREK IMAI

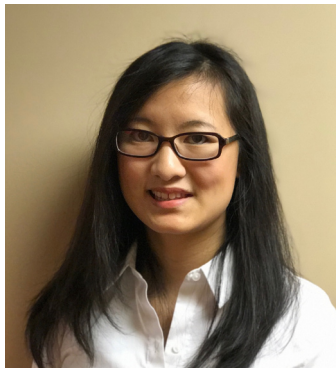

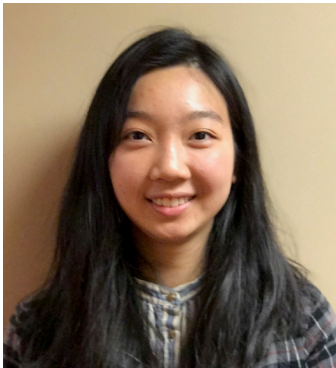
